Notice is hereby given that Sealed Bids for the construction of Okaloosa Island - Soundside Access No. 2 ITB PW 57-21 will be received by Board of County Commissioners of Okaloosa County at the Okaloosa County Purchasing Department, 5479A Old Bethel Road, Crestview, FL until 03:00 PM local time on September 29, 2021, at which time the Bids received will be publicly opened and read. No bids will be received after the designated time. The Project consists of grading, parking lot construction, sidewalk, stormwater management system, landscaping, fencing, demolition of an existing marginal dock, piles, bulkhead and other WORK as shown on the construction drawings and described in the specifications. The work is further defined as shown on the Plans and as described by the Contract Documents.

Please notify the receptionist upon arrival that you are attending the Bid Opening for the Okaloosa Island - Soundside Access No. 2 ITB PW 57-21 and the organization you are representing.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form. All terms, specifications and conditions set forth in this ITB are incorporated into your response. A bid will not be accepted unless all conditions have been met.

No printed copies of the bidding documents will be issued.

Bid security shall be furnished in accordance with the Instructions to Bidders.

A mandatory Pre-Bid conference will be held at 1:30 PM local time on September 14, 2021 at the Destin-Fort Walton Beach Convention Center located at 1250 Miracle Strip Pkwy SE, Fort Walton Beach, FL 32548.

All bids must be received in sealed envelopes reflecting on the outside thereof the Bidder's name and Okaloosa Island - Soundside Access No. 2 ITB PW 57-21. Any Bidder failing to mark outside of the envelope as set forth herein may not be entitled to have their bid considered. Okaloosa County is not responsible for lost or late delivery of bids by the U.S. Postal Service or other delivery services used by the respondent. Neither faxed nor electronically submitted bids will be accepted.

The Okaloosa BCC reserves the right to award the bid to the lowest responsive, responsible Bidder and to waive any irregularity or technicality in bids received. Okaloosa County shall be the sole judge of the bid and the resulting negotiated agreement that is in its best interest and its decision shall be final. Bids may not be withdrawn for a period of sixty (60) days after the bid opening unless otherwise specified.
